

**“SWITCH TO JOINT GUARD AND WIN \$5000 CASH” PROMOTION
TERMS AND CONDITIONS**

1. Information on how to enter and prizes form part of these Terms and Conditions of Entry. Entry into the promotion is deemed acceptance of these Conditions of Entry.
2. Entry is open to all Australian residents. Employees of Nature Vet Pty Ltd and their immediate families, and printers, suppliers, providers and agencies associated with this promotion are ineligible to enter.
3. The promotion commences on 1st April 2010 at 00.01 am (AEST) and concludes on the 31st August 2010 at 23:59 (AEST). Any entries received after this date are ineligible for the draw and no responsibility will be accepted for late, lost or misdirected entries.
4. To enter, consumers must purchase a Joint Guard for Dogs or Joint Guard for Cats product from a participating vet clinic or store during the promotional period.

Eligible entry may only be made by lodging a completed official entry form on the www.jointguard.com.au website, SMS their name and last 4 digits of the barcode to the number provided or send a mail entry to PO Box 147 GLENORIE NSW 2157. Each entry must be accompanied by the last 4 digits of the product barcode. Entrants must retain proof of purchase and may be asked to provide this information to the Promoter in order to claim a major prize.
6. One major prize winner of \$5000 cash and 3 Runner up prizes of “one year’s worth of Joint Guard” (value to the maximum of \$250 each) will be drawn at the end of the promotional period.
